FROM THE DESK OF THE GRAND BASILEUS



Brothers.

In light of the current situation related to COVID-19 as a rapidly evolving global threat, I have had the opportunity to have many discussions with the Supreme Council, our International Medical and Health Initiatives Committee, and our Grand Counselor and his team over the last week. Based on these discussions and in the interest of protecting the entire brotherhood and our communities in this time of great uncertainty, the fraternity is adopting aggressive new public health measures.

Other countries and organizations who have faced or are facing this crisis have proven that immediate, decisive public health measures are necessary to prevent the spread of the virus and protect public health. The steps we've been taking and those to come in the days ahead will help determine how Omega limits the spread of this virus and protects public health and the health of our brotherhood. While these measures may seem extraordinary, and to some extreme, these are extraordinary circumstances, and our response must rise to the challenge.

That is why, effective immediately, all district meetings have been postponed or cancelled (with the exception of the 13_h district meeting that occurs at our international meetings). Please see your district representatives for particulars as we are working through the specifics of virtual meetings and secure online voting. All chapters who choose to "meet" between now and June 1, 2020 should only do so by teleconferencing or video conferencing. All other fraternally-related gatherings of more than 10 people, scheduled to occur before June 1, 2020 are to be postponed or cancelled. This includes community forums and programs, social events, and others. All gatherings of less than 10 people should give consideration to postponement unless it can be assured that social distancing of at least 3 to 6 feet can be maintained between participants, messaging is provided around ill persons not attending, and there are adequate hand washing/sanitizing facilities. This directive is in line with that of the Center for Disease Control (CDC). If there is what the CDC considers to be substantial spread of COVID-19 in your community or the community of the event you are considering, you are directed to cancel fraternity-related events of any size. We will revisit these requirements the last week of May 2020.

The fraternity also discourages brothers from travelling to and from areas where there is known to be mild or moderate community spread of COVID-19. If you have traveled to an area where there is community spread, you are encouraged to self-quarantine outside of that community for at least 14 days before attending any fraternal events. Brothers who are ill with flu-like symptoms (fever, cough, etc.) should also self-quarantine for at least 14 days from the start of their illness.

We encourage brothers to keep your families and each other healthy. Develop and discuss a plan for what might need to change if you and your loved ones need to stay home for extended periods.

This situation continues to rapidly evolve, and we know brothers will have lots of questions. One of the questions you have is, "will we have our Grand Conclave in July?" We currently are finalizing our plans for a successful Grand Conclave. We will communicate to the brotherhood by June 1, 2020 if a decision is made to postpone or cancel the Grand Conclave and if so, how we'll conduct the business of our fraternity virtually. We may not have every answer today, but we will provide regular updates via our website and social media outlets and respond to your questions as quickly as possible. Be assured that Omega will continue to work closely with the experts on our International Medical and Health Initiatives Committee and our health partners to monitor developments around the world. The Supreme Council recently participated in an Emergency NAACP Tele-Town Hall meeting with the United States Surgeon General and other leading public health and policy experts and 21,000 participants to learn more about the coronavirus and in particular how it is impacting our communities. If we need to implement additional measures to protect each other, we will do so. The health of our brothers and our communities will always be a top priority.



March 25, 2020

Dear Friend.

In light of the increasing spread of coronavirus (COVID-19), on March 22, 2020 Louisiana issued a stay-at-home mandate in an effort to promote social distancing practices. As of last night, Governor Bel Edwards requested and the President granted a federal emergency declaration for Louisiana. As the illness spreads, my top priority is to keep you and your loved ones safe and informed. In the past week alone, we have seen more people fall ill, more people lose jobs, and more businesses close than we could have predicted. The people of Louisiana are strong and resilient folks who know firsthand how to rise from adversity.

While uncertainty and anxiety can be overwhelming, our ability to forge a path forward by working together with effective leadership will give us hope in the days and months ahead. That is why I am reaching out to you today to provide the most up-to-date resources and assistance during this challenging time. We applaud the tireless efforts of our mayors, governor, executives, and parish presidents. Please be sure to sign up for my e-newsletter here to receive the most up-to-date information as more information becomes available.

CORONAVIRUS UPDATES

As of March 25, 2020, the Louisiana Department of Health has reported 1,795 cases of coronavirus in the state and 65 associated deaths. Of those reported cases, 675 of them originate from Orleans Parish alone. To prevent the spread of the virus, Louisiana Governor John Bel Edwards has recently issued a stay-at-home mandate for all state residents. The Centers for Disease Control (CDC) has also released the following prevention guidance and recommendations.

- Covering your mouth when coughing
- Avoiding contact with people who are sick
- Washing your hands thoroughly and often for at least 20 seconds
- Staying home if you are sick
- Avoiding touching your eyes, nose, and mouth with unwashed hands
- Disinfecting commonly used home and work surfaces, including mobile devices

If you are experiencing fever, shortness of breath, or a dry cough, please seek immediate medical attention. Otherwise, please continue practicing social distancing and stay home as much as possible. If required to leave the home to purchase groceries or visit a medical provider, please keep six feet between yourself and those surrounding you.

We expect to vote by the end of this week to expand and increase the economic assistance that we've already approved. As soon as the bill text is available and printed, we will share the specific guidelines. We are ready and eager to pass a \$2 trillion bill to help with the below necessary services.

UNEMPLOYMENT BENEFITS

As a result of state-mandated stay at home policies and a severely weakened economy, far too many people have lost their jobs and need financial support to compensate for their lost wages. To apply for Unemployment Insurance, please file a claim with the Louisiana Workforce Commission online atwww.laworks.net. If you'd like to speak with a representative to discuss your claim, please call 1-866-783-5567. This line will be open daily to provide assistance from 8:00 AM CT to 7:00 PM CT.

SMALL BUSINESS RELIEF & ASSISTANCE

Entrepreneurs and small businesses make up the backbone of our economy but have seen severe losses as a result of rapidly declining demand. The U.S. Small Business Administration (SBA) is currently accepting applications from business owners in need of disaster recovery loans. FEDERAL FUNDING AND LEGISLATION

The U.S. Department of Homeland Security's Federal Emergency Management Agency (FEMA) recently announced a \$31,025,826.33 federal grant for the State of Louisiana for COVID-19 that is being provided to the state under the Robert T. Stafford Act. This funding will play a critical role in the recovery effort right here at home.

Just a few weeks ago, I voted to pass the Families First Coronavirus Response Act. While this bill was a necessary first step, I have continued to vocally advocate for getting immediate cash assistance into the pockets of Louisiana workers and families who have been hit hardest by this pandemic. Additionally, I have pushed for the suspension of credit card payments and late fees as well as a federal prohibition on evictions and utilities service terminations. While I am encouraged that some of these same proposals are being considered in earnest by my congressional colleagues in relief package negotiations, the time is now for common-sense solutions that help the most vulnerable among us. We cannot afford to wait.

If you have a moment, please read an op-ed wrote in The Advocate last week reinforcing the urgency of the moment and outlining the way I'd like to see the federal response take shape.

FOOD ASSISTANCE

Coronavirus has a dramatically different nutritional impact on both my younger constituents out of school and older constituents who are less mobile and more likely to fall ill by contracting the virus. For those individuals, there are important food resources available to help them right now.

Louisiana food banks are actively working to serve families in need by cooking and delivering meals to seniors and children out of school. They are also holding pop-up food distributions in underserved communities and offering SNAP application assistance for new workers. PAYING YOUR MORTGAGE OR RENT

The U.S. Department of Housing and Urban Development (HUD) in coordination with the Administration's Coronavirus Task Force authorized the Federal Housing Administration (FHA) to direct mortgage services to halt foreclosure and stop evictions from people in FHA-insured single-family homes for 60 days. If you are a leasee who cannot pay your rent on time, the apartment complex owner cannot initiate an eviction during this period.

KEEPING YOUR UTILITIES RUNNING

With dramatic job loss across the state and country, millions of Americans don't know how they will make ends meet and pay their power, water, electricity, and phone bills. In an act of leadership, the Louisiana Public Service Commission and the City of New Orleans have both prohibited the disconnection of utilities during this crisis. My hope is that the federal government will mandate similar prohibitions nationwide to help provide relief for struggling workers and families.

MENTAL HEALTH RESOURCES

The CDC has made recommendations on how to cope with the stress and anxiety that isolation can bring during this time. I encourage you to reach out to your family, friends, and neighbors with a phone call or other electronic forms of communication. Doing so is mutually beneficial and can help make somebody's day.

ADJUSTING TO FAMILY CHALLENGES

This time can be particularly challenging for parents juggling childcare, working, and, in some cases, caregiving. While this is difficult under normal conditions, today's reality requires an updated approach. Here are some ideas and resources to help keep your family functioning during this time.

- Keep a routine with your children at home similar to their normal school schedule.
- Communicate with all family members the importance of safety through social distancing and hand washing.
- Utilize digital platforms to video chat and conference with family and friends who are not in close proximity.
- Cook with your family members or have a special meal delivered to your loved ones or friends.
- Make and send care packages to people and organizations in need.

FILING YOUR TAXES

With the filing deadline right around the corner, the U.S. Treasury agreed to move Tax Day from April 15, 2020 to July 15, 2020 to give individuals and businesses more time to file without interest or penalties. For more information, please visit https://www.irs.gov/coronavirus.
