## **Domestic Violence Awareness Walk**










## Domestic Violence Awareness Luncheon

## National Kidney Foundation Walk/Run



#### "Are you making changes because you love yourself or because you hate yourself?"



FROM THE DESK OF THE GRAND BASILEUS

Dear Brothers:

The Supreme Council unanimously approved a new anti-hazing policy on September 9, 2019. It is being sent to our membership and will be posted on our website. Govern yourselves accordingly. The moratorium on MSP continues.

District Representatives shall enforce Omega's anti hazing policy to the letter. Any brother who violates the antihazing policy below shall be expelled.

#### ANTI-HAZING POLICY

- It shall be policy that hazing will not be tolerated, condoned nor endorsed as explicitly stated in the following;
- The Omega Psi Phi Fraternity, Inc. embraces the principles contained in the Statement of Position on Hazing as promulgated by the Fraternity Executives Association (see statement below). However, for its own intent and purposes, the Omega Psi Phi Fraternity, Inc. espouses the following as its official Statement of Position on Hazing; to wit:
- 3. Omega Psi Phi Fraternity, Inc. has a zero-tolerance policy that strictly prohibits and expressly denounces the practice of hazing in any form before, during and after the Membership Intake Process. pre-initiation activities for any of its chapters or by any of its members against any person seeking admission to the organization. The policy expressly prohibits all acts and forms of hazing, before, during and after the Membership Intake Process. 'Hazing' is defined as any reckless or intentional action taken or any situation created which produces mental or physical discomfort, embarrassment, harassment or ridicule. Such activities and situations include, but are not limited to paddling in any form; creation of excessive fatigue; creating or inflicting physical and/or psychological shocks; conducting quests, treasure hunts, scavenger hunts, road trips or any other such activities carried on outside the confines of a house/domicile; public wearing of any apparel or paraphernalia which is conspicuous, not normally in good taste or otherwise banned; engaging in public stunts and buffoonery; morally degrading or humiliating an individual(s) through words or deeds; conducting late (after established hours) sessions which interfere with or prohibit the pursuit of scholastic attainment or productive work; and the conduct of any activities, express or implied, which are not consistent with the Cardinal Principles espoused by the Fraternity or academic missions of the colleges or universities where chapters of the Fraternity may exist. The express or implied consent of a person to any such actions shall not be considered as an exception to this policy and is not defensible as a violation thereof.
- Member is liable for all damages/costs incurred for any claims arising from acts of hazing. Grand Counselor will pursue this.
- Any individual interested in membership or seeking membership who allows himself to be hazed will be banned indefinitely from membership in Omega Psi Phi Fraternity, Inc.

## **Recommendation Procedures—2020 Grand Conclave**

Greetings Brothers of the Mighty 9th District. Please see attachments about the Recommendation Procedures for the 2020 Grand Conclave below. Also see timeline instructions below.

2020 Grand Conclave Recommendations Timeline:

Nov 1 - Committee, through the Executive Director, sends out procedures and request for proposed policy/ procedures changes and amendments to Fraternity C&BL.

• Included in this request will be instructions on the handling of Recommendations that were not considered in New Orleans (2018).

• Brothers will be instructed that pursuant to Robert's RONR, any action tabled in New Orleans expired at the close of the final Plenary Session.1 Therefore, recommendations submitted in advance of the New Orleans Grand Conclave, but not considered before the end of the last Plenary Session, will need to be resubmitted to be considered in Tampa (2020).2

• As a courtesy, the authors of those recommendations will be contacted by the Recommendations Sub-Committee chairman following the November 1 announcement to ascertain their preference for having, or not having, their proposal considered in Tampa - either with or without changes. Any Brother may (re) submit the proposal, whether he was the original author or not, and irrespective of the preference of the original author. The contact will be made to

#### Submission Deadlines

January 19, 2020 (exactly 180 days before Conclave convenes) - Proposed Constitutional changes must be submitted to the Executive Director at executivedirector@oppf.org and the Recommendations Chair@oppf.org. (Form 3A)

March 19, 2020 (exactly 120 days before Grand Conclave begins) - Proposed Bylaws changes must be submitted to the Executive Director at executivedirector@oppf.org and the Recommendations Chair @oppf.org (Form 3A)

April 18, 2020 (Exactly 90 days before the Grand Conclave begins) -

1) Proposed policy changes not affecting the Fraternity C&BL must be submitted to the Executive Director at executive director@oppf.org and the Recommendations Chair @oppf.org

#### 2) Proposed C&BL

1 TIME LIMITS ON TAKING A QUESTION FROM THE TABLE A question that has been laid on the table remains there and can be taken from the table during the same session or if the next regular business session will be held before a quarterly time interval has elapsed. If not taken from the table within these time limits, the question dies, although it can be reintroduced later as a new question. (Roberts Rules of Order Newly Revised, p. 301)

2 Article V Section 6 - Parliamentary Authority: The rules contained in the current edition of Robert's Rules of Order Newly Revised shall govern meetings of the Fraternity in all cases to which they are applicable and in which they are not inconsistent with these Bylaws and any special rules of order the Fraternity may adopt for a specific meeting. (Omega Psi Phi Constitution and Bylaws p. 9) amendments timely received are to be distributed to the Chapters through the Grand Keeper of Records and Seal, the Executive Director and the Recommendations Chair. (Form 3A)

May 18, 2020 (Exactly 60 days before the Grand Conclave begins) - Proposed policy changes timely received by the Executive Director that do not affect the Fraternity C&BL are to be distributed to the Chapters through the Grand Keeper of Records and Seal, the Executive Director and the Recommendations Chair.






